PLEASE CAREFULLY READ THIS AGREEMENT WHICH CONTAINS THE TERMS AND CONDITIONS UNDER WHICH YOU ARE ACQUIRING A LICENSE TO USE MLDB. IF YOU DO NOT ACCEPT THE TERMS AND CONDITIONS OF THIS AGREEMENT PLEASE DO NOT DOWNLOAD, INSTALL, OR ATTEMPT TO USE THE SOFTWARE. THE SOFTWARE IS ALSO PROTECTED BY COPYRIGHT LAWS AND INTERNATIONAL COPYRIGHT TREATIES, AS WELL AS OTHER INTELLECTUAL PROPERTY LAWS.

1. LICENSE TERMS

- a. Grant of License:** Subject to the terms and conditions of this Agreement, Datacratic grants You a non-exclusive, non-transferable royalty-free license for Your personal use and to build prototypes of software applications that will interface with the Software and/or to make modifications or configuration changes through plug-ins that may be provided to the Software from time to time. Under no circumstances shall this license include any use in a business production mode or use in developing any software for use in a business production mode or for commercial licensing, distribution or other disposition or any other use or distribution intended for or directed towards commercial advantage or private monetary compensation.
- b.** You acknowledge that the Software contains confidential information and know-how and You shall not use such confidential information or know-how except to the extent necessary to exercise the rights granted to You hereunder. If You use open source software in conjunction with the Software, You must ensure that Your use of such open source software does not: (i) create, or purport to create, obligations on Datacratic with respect to the Software; or (ii) grant, or purport to grant, to any third party any rights to or immunities under Datacratic's intellectual property or proprietary rights in the Software.
- c. License Restrictions:** For greater certainty, You shall not:

- i.  - iv. develop any prototype or application using the Software and any open source software that results in any program file(s) that contain code from both the Software and any open source software (including without limitation libraries), if the open source software is licensed under a license that requires any "modifications" be made freely available. You also may not combine the Software with programs licensed under the GNU General Public License ("GPL") in any manner that could cause, or could be interpreted or asserted to cause, the Software or any modifications thereto to become subject to the terms of the GPL; or
 - v. violate any law, statute, ordinance, contract or regulations.
- d. Audit Right:** Datacratic reserves the right to use the capabilities of the Software and/or request no more than once (1) per annum access to systems, documentation and personnel to verify your compliance with the terms of this Agreement. In the event that you are found to be in breach of this Agreement, Datacratic reserves the right to immediately terminate your use of the Software and to pursue other legal remedies available to Datacratic.

It is your responsibility to ascertain the level of such fees and to pay such fees. Datacratic will have no liability in respect of third party fees.

3. DATA TERMS

- a. **Title:** All right, title, and interest (including all intellectual property rights) in, to and under the Software (including all copies thereof) shall remain with Datacratic. You shall retain all ownership rights (including all intellectual property rights) in any Applications that You create and utilize with the Software, except that all ownership rights (including all intellectual property rights) to any element of the Software incorporated into or embodied in Your Applications shall remain with Datacratic and its licensors.
- b. **Your Data.** As between Datacratic and You, You exclusively own and shall retain all right, title and interest (including without limitation all patent rights, copyrights, trademark rights, trade secret rights and all other intellectual property rights therein) in and to the content on your devices and within any account which you link to the Software (“Customer Data”). 5. TERM, TERMINATION AND CHANGES TO THIS AGREEMENT AND THE SOFTWARE

- a. **Term and Termination:** This Agreement shall continue for as long as You use the Software, however, it will terminate, without notice from Datacratic, if You fail to comply with any of its terms or conditions. You must, upon termination, destroy all copies of the Software. You may terminate this Agreement by destroying all copies of the Software under Your control and notifying Datacratic of such destruction. In addition to this Section, the Sections entitled Disclaimer of Warranties, Limitation of Liability, Title and General Provisions shall continue in force even after any termination of this Agreement.
- b. **Updates:** Datacratic may, without obligation, provide at its discretion, updates or upgrades to the Software and may update or modify this Agreement from time to time in its sole discretion.
